

## Roadmap to becoming a Certified Pharmacy Technician

- Complete 50-hour class.
- Register with the Ohio State Board of Pharmacy as a Pharmacy Technician Trainee.
- Complete 80-hour clinical externship.
- Complete 300 work hours with a board-approved on-the-job training program with companies such as CVS or Walgreens.
- Pass the PTCB exam and become nationally certified.
- When training is complete, the pharmacist will sign off on student hours, and student will submit documentation to the state to become a Certified Pharmacy Technician.
